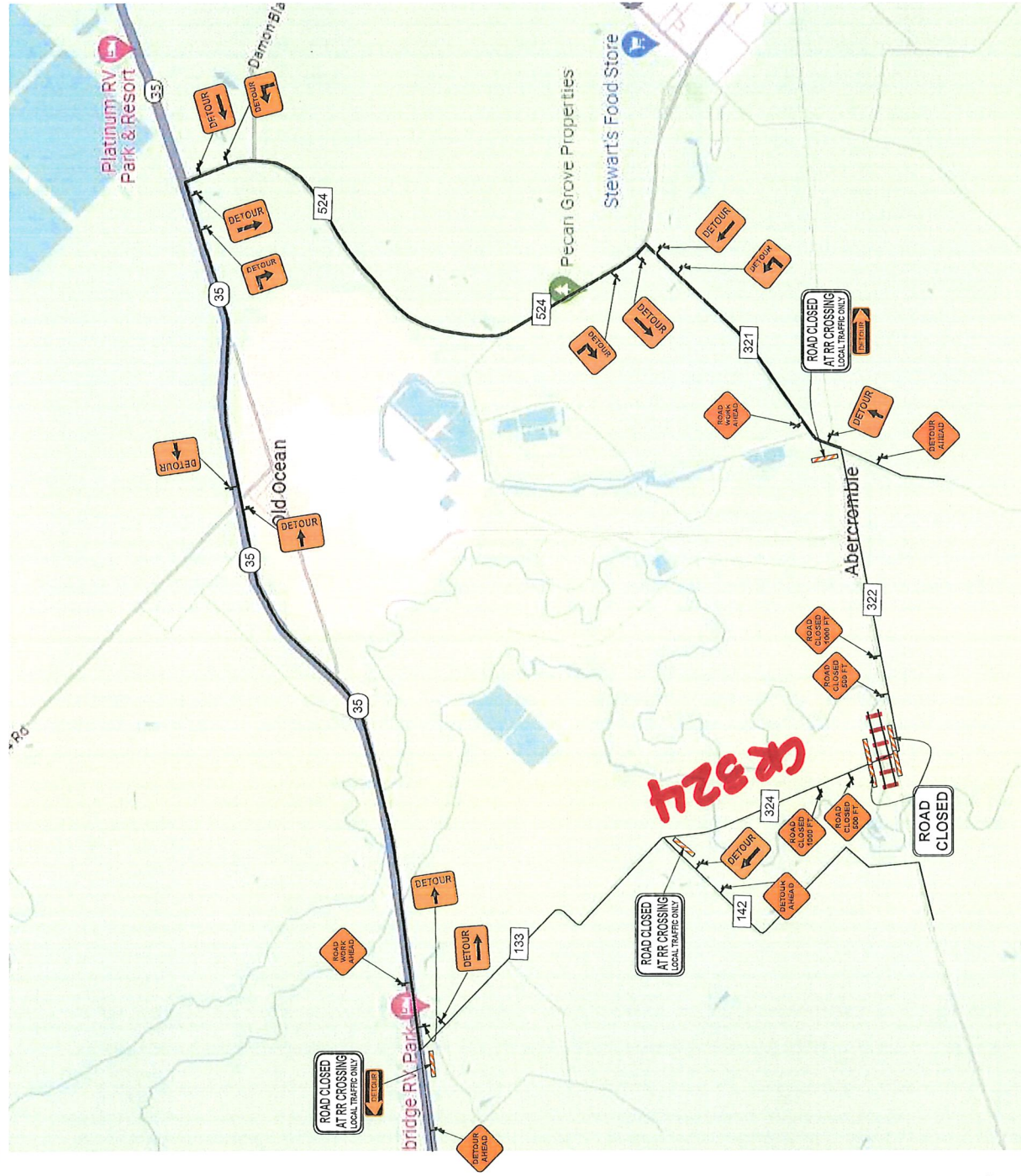

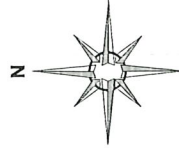
DETAIL "A"
