Brazoria County, TX entered into a contract for Disaster Monitoring Services with Tetra Tech, Inc. (Tetra Tech) for a period beginning on August 18, 2021 through March 31, 2022 with the option to renew the contract term for up to four (4) additional one (1) year periods.
