

As of 7/23/2024 - Total Base Tax: \$4,843,231






DOLLAR RANGE CHART

FOR BRAZORIA COUNTY













BRAZORIA COUNTY TOP 10 REPORT AS OF JULY 1, 2024

The following represent the Top 10 outstanding delinquent accounts presently due to Brazoria County which are not already uncollectible due to the statute of limitations, over 65 deferrals, roll backs or owned by the County from a tax foreclosure sale. The amounts shown reflect base taxes due.

1. FLOWORKS INTERNATIONAL LLC- (2023) \$60,412

This is an inventory account located in Pearland. The taxpayer made an appropriate 42.08 payment and has filed suit against the appraisal district. No action can be taken until the valuation lawsuit is complete. It is possible a portion or all the outstanding taxes shown due will be removed.

2. BROP, LLC- (2023) \$45,797

This is a commercial retail center located in the Alvin ISD part of the City of Pearland. The taxpayer made an appropriate 42.08 payment and has filed suit against the appraisal district. No action can be taken until the valuation lawsuit is complete. It is possible a portion or all the outstanding taxes shown due will be removed.

3. DR SIENNA VILLAS INVESTMENTS LP- (2023) \$32,016

This is a real estate account located in Freeport. The taxpayer has been delinquent in the past. We are in contact with them and the lender to obtain payment. if necessary, we will file a suit to collect the taxes.

4. ELLIOT OIL & GAS- (2023) \$ 27,324

This company is habitually delinquent. Currently, they owe taxes on fifty-four (54) mineral accounts consisting of working interests and pipelines. We have contacted the company and they have requested another payment agreement. We will work with them on paying over a brief period of time.

5. KINDER MORGAN TEJAS PIPELINE LP- (2022 & 2023) \$25,616

There are eleven (11) pipeline accounts that were late supplements to the tax roll earlier this year. A large payment was made in June 2024, but this balance remains. We expect to have this paid in the near term.

6. PEARLAND OFFICE CENTER, LLC- (2023) \$ 24,770

This is the Pearland Office Park located on Smith Ranch Road. We are contacting the owner and reaching out to the lienholder to get the taxes paid. If that fails, we will file a suit to collect the taxes.

7. AURA AKA, LLC- (2023) \$ 20,092

This is a 2.24-acre commercial development off Broadway. We are contacting the owner and reaching out to the lienholder to get the taxes paid. If that fails, we will file a suit to collect the taxes.

8. CLUTE APARTMENTS 2 LTD.- (2023) \$19,762

This is an apartment complex on Dixie Drive in Clute. The taxpayer made an appropriate 42.08 payment and has filed suit against the appraisal district. No action can be taken until the valuation lawsuit is complete. It is possible a portion or all the outstanding taxes shown due will be removed.

9. SILVER MAPLES APARTMENTS LLC- (2023) \$ 18,900

This is an apartment complex in Pearland. The taxpayer made an appropriate 42.08 payment and has filed suit against the appraisal district. No action can be taken until the valuation lawsuit is complete. It is possible a portion or all the outstanding taxes shown due will be removed.


10. SAMTX BHYC MARINA LLC- (2023) \$ 13,052


