Mayor Powell,

I got with Rodney yesterday and came up with the following estimate. This is to expand the road inside the gate and create a new wider radius on the outside so that the 18-wheelers can make their deliveries. I believe that an 8" lift of 12% cement stabilized crushed concrete should complete the initial job. After all has settled, we can add black base or hot mix to top it and that would need a different estimate depending on how much you would want to pave.
