

WHEREAS, the Harris County Cultural Education Facilities Finance Corporation, pursuant to section 147(f) of the Internal Revenue Code of 1986, as amended (hereinafter referred to as the "*Code*"), after reasonable public notice (hereinafter referred to as the "*Notice*"), a copy of which is attached hereto as *Exhibit A*, has conducted a public hearing on a plan of finance including the proposed issuance of its limited obligation revenue bonds in one or more series and in one or more years in an aggregate approximate maximum principal amount of \$1,110,000,000 (hereinafter referred to as the "*Bonds*"), to finance or refinance projects described in the Notice (herein referred to as the "*Projects*"), including projects located in Brazoria County, Texas (the "*County*"), for all of which Memorial Hermann Health System, a Texas non-profit corporation, or an affiliate is the legal owner or principal user; and

Section 1. The County Judge, the County Commissioners, and the County Clerk and other officers of the County, or any of them, are hereby authorized to execute and deliver such endorsements, certificates, instruments, documents, or other papers and to do all other things necessary or advisable to give effect to the intent and purpose hereof.
