Charles D. Gooden Consulting Engineers, Inc. requests additional services to redesign the proposed ditches on Forest Loop due to Dow's rejection of the current design.

Background

CDGCE has coordinated with Dow regarding two existing 6" gas lines on Forest Loop. The location and depth of these lines has been determined by Dow. The project surveyor, Gormly Surveying, has incorporated the location and depth of these lines into their survey files. This file has been delivered to CDGCE.

The current design would have resulted in 1.33 feet of cover between proposed ditch culverts and the existing gas lines. Mr. Chrisopher Graves of Dow informed CDGCE on October 23, 2023 that the current design could not be accepted.

Schedule and Proposal

The ditches on Forest Loop will be redesigned to use the existing culverts as a high-point. We anticipate this process will take two weeks to complete. Our additional services request is for a lump sum of \$5,500.00 for the ditch redesign. The resulting hourly rate for this task is \$68.75/hour, which is less than the contract hourly rate of \$90.15 for a "Technical Manager — Civil".

With the ditch redesign completed, the drawings for this project will be resubmitted to Dow for their review. The coordination will be complete when "No Objection" correspondence is issued by Dow. Once the "No Objection" correspondence is received, CDGCE will issue sealed drawings to the County for construction. can be sealed and submitted to the County, and construction will be clear to begin.
