Please accept this letter as a formal request to establish the 2026 Interlocal Agreement between the City of Pearland and Brazoria County for asphalt road paving services.

Interlocal Paving Services for Fiscal Year 2025 was approved by the Pearland City Council (R2025-125) and executed by the Mayor on July 28, 2025. The 2025 plan allowed for paving services along Roy Rd, Veterans Dr, Old Chocolate Bayou Rd, and Plum St. These Improvements are anticipated to commence in October 2025. In response to Brazoria County's Interlocal Agreement Project Request Summary for FY26 and accompanying letter dated September 5, 2025, The City of Pearland provides the following list of proposed roads for consideration of interlocal paving services in FY26.

The City requests a continued combination of paving services from Brazoria County to include an asphalt overlay and traffic control to the streets listed below in FY26.


