WHEREAS, Brazoria County, Texas intends to make certain improvements to the (Texas Gulf Coast Regional Airport); and

WHEREAS, the general description of the projects is described as: replacement of an Airport Rescue Fire Fighting (ARFF) vehicle; and

WHEREAS, Brazoria County, Texas intends to request financial assistance from the Texas Department of Transportation (TxDOT) for these improvements; and

WHEREAS, total project costs are estimated to be \$ 700,000, and Brazoria County, Texas will be responsible for the total project cost and will seek 95% reimbursement from TxDOT; and

NOW, THEREFORE, BE IT RESOLVED, that Brazoria County, Texas hereby directs L.M. "Matt" Sebesta, County Judge to execute on behalf of Brazoria County, Texas, at the appropriate time, and with the appropriate authorizations of this governing body, all contracts and agreements with the State of Texas, represented by the Texas Department of Transportation, and such other parties as shall be necessary and appropriate for the implementation of the improvements to the Texas Gulf Coast Regional Airport.
